• Admin Report

Principal Replacement: Mr. Bourcet will be retiring January 1st, 2015. A member of PAC may be allowed to sit in on the hiring process for replacement. Jody makes a motion for Sherri Lock to sit in on the meetings to represent PAC if this opportunity is given. Tina seconds the motion. All were in favor. Motion Passed.

Kitchen update
